8. Master meter reads and water report loss

Water loss analysis after billing has been taken over is at 2.18% for October-January. Contractors were found taking water but never paying for it. The water loss can be accounted for based on the water that was used by the contractors. Also, due to a recent fire down Draco, the Fire Department was able to utilize a fire hydrant and put out the fire. GWSD needs to have the money to afford what needs to be done. Once infrastructure, valves, etc. are put into place and roads can be built upon it.

9. Proposals:

- 1. Review and approve Proposal for Deep dive clean of community water tanks:
  - a. NVS from Colorado: Clean and inspect that 200 kilogram 33ft diameter by 33ft high steel welded on grade water tank. Sentiment removal of up to 3 inches. DVD video inspection and written report. A \$3,500 proposal is good for 90 days. This would be for one water tank.
  - Advanced Diving Services Incorporated: Clean and inspect 300,000 gallons, 33x33ft water tank. Sentiment cleaning up to 1 inch deep. Each extra cubic yard is \$35 dollars \$2,000 per tank. Additional charges for mobilization.
  - c. U.S Water Commercial Dive Team: Dive inspection, sentiment removal up to a half inch. \$9,900 for one tank.

Salvador Nava proposes that the board accept the Advanced Diving Services proposal in the amount of \$2,500 per tank equaling \$5,000 for both tanks. Total expense cap is at \$6,000, anything above this must be approved first.
