**4. Financial Reports:** Bookkeeper, Anna Bond, presented the financial reports. She reported Gamerco has been over paying for the amount of water that is actually used. Gamerco is paying for around 2.7 million gallons of water and losing about 1 million gallons of it. With the help of getting meters properly linked up to addresses, locating major leaks, and stressing customers paying their bills on time can help narrow down how much water should actually be purchased. **5. Report by Water Operator:** Teresa Garcia reported that water samples were taken and sent off. With the help of Resource Wise, Gamerco worked to fix meters that were not properly synced with the billing system, Quikwater, and the meter reading software, Ready Manager. ## 7. New Business:

**A. Begin work on Diamond St. to try and locate any water leaks**

GWSD is working to locate a water leak located on Diamond Street. Weather conditions have made it difficult to access, however, work will begin on the road this month. GWSD is interested in getting leak detectors added throughout Gamerco to locate issues similar to this in a timely manner.

**B. Water Meter Audit**

A water meter audit has been done with the help of Resource Wise to properly link up meters with service addresses. This helps ensure customers are being charged for the correct amount of water they are using at the address.

**C. Clarification on payment methods**

GWSD has made some changes to the payment methods that are accepted for bill payments. Gamerco will now accept: Money orders, cashier's checks, personal checks, business checks, and credit/debit cards (only available online). If a check is bounced or returned, a \$35 return fee will be placed on the customer's account.

**G. Water Disconnection Schedule Update**

GWSD has decided to update the water disconnection schedule to help customers avoid falling behind on their bill payments. If a bill has not been paid 7 days after the date it is due, a late notice will be mailed out to the customer. If a bill has not been paid 14 days after the date it is due the customer's account will be charged with a late fee of 10% the

total amount due and they will also receive a shutoff notice at the address. If the bill is still not paid within 3 days of the shut off notice, the water will be turned off.
