- a) Update on Gamerco Roads: Jason has been talking to McKinley County Manager Dimas and they are ready to begin hauling the millings to our area. We need to drive the roads and determine which will need to be completed first. We also need to be cognizant of the valve project, and only do the roads that the valves are completed on.
- b) Increase on sewer rate: We will be working on the rates in the next couple weeks. It appears that the City of Gallup may be charging us incorrectly on our sewer usage. We will need to reach out to the City to determine the reasoning and negotiate the billing. Once this is completed, we will have a better idea of how to move forward with the rates to our customers. We have some commercial customers who have impacted this, and will need to be addressed. On another note Eagle Ready Mix's billing has been corrected to now have them pay for sewer. We do not know why they were removed, but there is no written agreement on file.
- c) Community Clean Up: The By-Laws and Covenants are available for all residents of the area. We will be looking into how we can uphold them and how we can get cooperation in cleaning up the area. Angela will be checking into getting a couple roll-offs to put in the area for a community clean-up day soon.
- d) Procedure for customer's additional trash cans: There is a procedure in place Clint has taken inventory of the trash cans and those residents who have more than one are being charged the additional \$18.
